

ABOUT THE CONTEST AND HOW TO PARTICIPATE

The Kaun Banega Crorepati Contest (hereinafter referred to as "**Contest**") is hosted by Multi Screen Media Pvt. 1. Participants must be citizens of India and residing in India and must be registered member of Kaun Banega Crorepati Official Contest. Residents of other countries and non-citizens of India are not eligible to participate.
2. The Participants must have attained the age of 18 years to participate in the Contest. For the Participants who have not attained the said age of 18 years are permitted to participate in the Contest with the prior approval of their parents/guardians.
3. Employees, agents and promoters (including their immediate family members) of MSM and any of their divisions, affiliates and subsidiaries, and others associated with the Contest in any manner, are not eligible to participate in the Contest.
4. The Participants shall be required to provide basic information about themselves like name, address telephone number, and email address in order to register and participate in the Contest.
