Terms & Conditions

1. Only children between the age group of 7-12 years of age can participate in the Auditions (the "Participant(s)"). All Participants must be accompanied by their natural/legal guardian on the date of audition. Participants agree that participation in this Contest by any Participant will be deemed as participation out of free will and with the prior consent and knowledge of the Participant's parents/legal guardians, and is not due to force, coercion or any undue influence.
2. The parents/guardians accompanying the Participants shall carry food, water and other required items medicines if required for the Participants and self.
3. Entry to Auditions is on 'first-come-first served' basis and does not involve any entry fee or cost for participation to the Participant. MSM shall not be responsible or held liable for any travel cost/fee/any other costs incurred by the Participants with respect to the Auditions. Any instances of entry fee or cost being charged to Participants for the Auditions should be immediately brought to the notice of MSM on the following address and/or website:

4. Participants shall be required to fill an entry form for participating in the Auditions.
5. Participants shall carry their own audio CD which is in good working condition for the purposes of rendering performance in the Auditions. It is advisable to carry more than one audio CD in case of any failure in the functioning of audio CD at the time of performance. Participants shall submit the audio CD to the team deployed by R&N TV for Auditions. The Auditions shall be video-taped for jury preview at a later stage, and the Participants will be short listed on the basis of their recorded performance in the Auditions. The length of the song must not exceed 2 minutes and it should be on an audio CD format. **MP3 audio is not accepted.** The song choice must be of Hindi or regional language Indian songs. All Indian songs available on standard Indian music labels are only acceptable.

For Participants submitting a medley, the songs must be edited properly. Un-edited or badly edited songs shall lead to disqualification of Participants. At the time of submission of audio CD, the Participants must write down his/her name, the name of the song alongwith the album/film from which it is taken, and the name of music company which has published the music of the film/album. Participants are prohibited from playing music owned and copyrighted by T-Series, Yash Raj, Big Music and any international music labels for their audition performance.

6. Participants must be citizens of India residing in India. Non-resident citizens of India are eligible to participate in the Auditions provided they hold a valid Indian passport.
7. Participants who are under any contract which will prohibit him/her from entering into any management contract/performance recording contract and/or merchandising contract are prohibited from participating in the Audition.
8. Participants should not have any criminal record and/or be declared as an insolvent and/or of an unsound mind.
9. All Participants must carry proof of age and photo identity such as birth certificate/ ration card/ driving license/ passport/ voter's ID/ pan card for photo identity proof.
10. A reasonable level of skill in dance is required to participate in the Auditions.
11. Only selected Participants will be notified by telephone/email/fax/letter about the further rounds of participation and other details by R&N TV on behalf of MSM. Decision of MSM in all matters pertaining to the Auditions and selection of Participants shall be final and no correspondence in this regard shall be entertained.
12. All expenses incurred by the Participants in connection with the Auditions, including but not limited to costume, make-up, travel & food expenses, shall be the sole responsibility of the Participants. Participants shall not be given any additional space like dressing room or make up room for change of costumes or for make-up or for any such other purpose.
13. Please note that there is no provision for entry to Auditions through SMS registration and expenses incurred in this regard shall not be reimbursed
14. MSM reserves the right to change, modify, cancel or close the scheduled Auditions at any given time without incurring any liability whatsoever.
15. By entering the Auditions, the Participants waive all copyrights, rights of publicity and any related rights and consents to MSM's right to picture, tape or

portray him/her as a Participant in the Audition, and to exhibit this material in any and all media now existing or hereinafter created, including without limitation television, film, radio and print media, without any compensation whatsoever for advertising and publicity purposes, except where prohibited by law. The Participants also consent to MSM's right to use his/her name, voice or picture, or the content of his/her Auditions.

16. Participants grant MSM irrevocable consent in perpetuity to the use of the sound recordings, photographs, video tape, and illustrations taken during or in connection with the Audition, in any and all applications including but not limited to advertising, commercials, promotion, stories, text, articles, illustrations, copy and commercial exploitation, in any and all media forms, including but not limited to radio, broadcast and television, newspapers and magazines at any time without the Participants further knowledge or consent.
17. Participants shall indemnify and hold MSM harmless from any claims, expenses, damages or any other payments of any kind arising in any way out of the use of participants name, image, voice and likeness.
18. Participants release MSM and their respective officers, directors and employees from any and all liability resulting from conducting of the Auditions and Participants' participation in the Auditions.
19. Employees, agents and promoters (including their immediate family members) of MSM and R&N TV, and of its divisions, affiliates and subsidiaries, and others associated with the Audition in any manner, are not eligible to participate in the Audition.
20. MSM/R&N TV reserves their right to select and declare or not to declare the Participants who are selected in the Auditions. No phone calls will be entertained regarding the status of selection.
21. It is the responsibility of the selected Participants to make themselves available for the next stage of participation and in the event such selected Participants do not show up for next stage of participation, MSM may, at its discretion, afford another opportunity to appear or disqualify them.
22. Participants release MSM and its respective divisions, affiliates, subsidiaries, branches, directors, officers, employees and agents, as well as all others associated with the development and execution of the Auditions, from and against any and all liability with respect to or in any way arising from this Auditions, including liability for personal injury, except where prohibited or limited by law.
23. MSM reserves the right to change the terms and conditions of Audition as contained herein and to alter or terminate the Audition at any time without prior notice.

24. Non conformance of the rules & regulations including the terms & conditions stated herein shall result in disqualification from participation in the Audition.
25. MSM shall be entitled to take necessary action for and against the Participants or any interested/intended Participants for any misbehaviour and/or for creating any unrest at the Venues on the day of the Auditions. Any disturbance, illegal or unethical act in or outside the Venues and/or related to the Show will lead to immediate disqualification.
26. By participating in the Audition each Participant agrees to follow and accept the 'rules & regulations' including the terms & conditions stated herein and to be bound by any decisions made by MSM/R&N TV, including any interpretations of these Audition rules & regulations.
27. For those interested in participating and could not make it to the Auditions can send a video CD containing their recorded dance performance to the below mentioned address of the production house alongwith their full details (Name, Age, Address and Contact number) and photocopies of age proof and photo identity. Such applications will be rejected, if the video CD is tampered/not readable or not properly labelled.
