OFFICIAL RULES FOR UPLOADING CONTENTS

ELIGIBILITY AND CONDITIONS:

1. Program : "Champion Chaalbaaz No. 1".
2. Registration & Registered User: The participant shall register his/her name by completing certain processes detailed on Multi Screen Media Private Limited, formerly known as SET India Private Limited's ("SET") micro-site namely www.setindia.com/chaalbaaz/index.php ("Site") created on website www.setindia.com before participating to upload his/ her contents relating to anecdotal pranks/ tricks ("Contents") on blog titled as "Champion Chaalbaaz No.1 --Mia Fekoo" ("Blog") which is available on various free websites.
3. Contents : Registered User may upload any of his/her anecdotal prank/ trick by way of a video film of maximum 7 (seven) minutes using any standard video shooting device or by way of a write up maximum in 500 (five hundred) words on self experience. The Registered User can also share his/ her prank/ trick/ experience by dialing a Special Code/ Interactive Voice Response System No. 5052525 ("IVR No."). (Call charges will be upto Rs. 7/- per minute).
4. The Registered User must be citizen of India residing in India. Residents of other countries and non-citizens of India are not eligible to participate.
5. Employees, agents and promoters (including their immediate family members) of SET, its divisions, affiliates and subsidiaries, including all others associated with the Program in any manner, are not eligible to upload any Contents on this Blog.
6. A reasonable level of skill is required to upload the Contents on this Blog. Registered User may upload as many Contents as he/ she desires once a day and the Content received before 8 pm between Monday and Friday - till 17th January, 2008 will be considered valid.

7. For uploading Contents, each Registered User agrees to follow these Official Rules and to be bound by any decisions made by SET, including any interpretations of these Official Rules, applicable for uploading the Contents on Blog.
8. SET and its divisions, affiliates and subsidiaries, and their respective agents and representatives, are not responsible for any loss of opportunity to upload the Contents, for any reason whatsoever including, any problems caused due to any technical fault or deficiency.
9. The Registered User shall upload the Contents of his/ her own experience / knowledge and not of any other person/ user.
10. SET and its associates shall verify the Contents with its standards and practices before actual displaying the same on its Blog and shall be entitled to refuse/ reject to upload the same on its Blog without giving any reasons. SET and its associates shall have right to edit the Contents before uploading the same on its Blog.
11. On displaying the Contents, the Registered Users' name and contact details will be published on the Blog below his/ her Contents.
12. SET has the right to modify the access to its Site, reduce the number of options available to upload the Contents by Registered User.

15. SET reserves the right to change the conditions of this participation by the Registered User and to alter or terminate the same at any time without prior notice.
 16. The participation is void where prohibited by law. All relevant national and local laws apply. All disputes to be settled within the jurisdiction of the Courts in Mumbai only.
