

## RULES & REGULATIONS GOVERNING “GHAR BAITHE JEETO JACKPOT” CONTEST IN KAUN BANEGA CROREPATI -

### I. CONTEST DESCRIPTION:

“GHAR BAITHE JEETO JACKPOT” (“**Contest**”, “**GBJJ**”) is a contest that will be held on the show “Kaun Banega Crorepati ” (“**Show**”) for home viewers. The contest will be telecast on Sony Entertainment Television (“**Channel**”) which channel is owned by Multi Screen Media Private Limited and/or its affiliates (together known as “**Company**”).

### II. DEFINITIONS:

1. “**Participant (s)**”: Any person(s) who participates in the Contest and who (i) is above eighteen (18) years of age; (ii) is a citizen of India residing in India and (iii) enters the Contest in accordance with the rules stated below. Employees of the Company, of the Producer, of the advertising agency which has been appointed from time to time, and also employees of the main sponsors; and members of their immediate family; persons other than Indian nationals, or Indian nationals living out of India, or those who do not qualify under the definition of resident of India as per the Income Tax Act, 1961 or those not conversant in spoken Hindi, are ineligible to enter the Contest.
2. “**Contest**”: General knowledge quiz for Home Viewers entitled “GHAR BAITHE JEETO JACKPOT”.
3. “**GBJJ Question**”: A question aired on the Channel to call for entries for Ghar Baithe Jeeto Jackpot Contest.
4. “**Shortlisted Participant (s)**”: A list of Participants per Episode who have given correct answer to a GBJJ Question in the valid format and have been selected through a random selection for telephonic auditions.
5. “**Episode Winner(s)**”: The Shortlisted Participant(s) who has answered the GBJJ question correctly in the valid format and post audition is / are selected for call-out on the Show. The Episode Winners are eligible for the Episode Prize.

6. **“Episode Prize (s)”**: The prize money of Rs. 1,00,000/- (Rupees One Lakh Only) that the Episode Winner is eligible for, prior to accepting to answer the Jackpot Question.
7. **“Jackpot Question (s)”**: An additional question that the Episode Winner is given on the Show call-out, to play for the Jackpot Prize.
8. **“Jackpot Winner (s)”**: The Episode Winner (s) who chooses to attempt the Jackpot Question and answers it correctly on the Show call-out.
9. **“Jackpot Prize (s)”**: The minimum prize money of R. 2,00,000/- (Rupees Two Lakhs Only), or any other amount as may be advertised / defined from time to time by the Company, and a carry forward of Episode Prize from previous episode (s) if any, that the Episode Winner is eligible for after answering the Jackpot Question correctly.
10. **“Cluster”**: A database of all valid and correct entries segregated from all entries received for GBJJ Questions over a pre-defined time period or number of questions.
11. **“Show”**: “Kaun Banega Crorepati ” which is being produced by BIG Synergy Media Limited for initial exhibition on the Channel. It also includes, but is not limited to, recordings of the Contest in the Studio (including any seasonal *special(s)* recording).
12. **“Home Viewers”**: Persons viewing the Show during its initial exhibition on the Channel.
13. **“Episode”** An episode of the Show.
14. **“Producer”**: means the Producer of the Show which is Big Synergy Media Ltd.
15. **“Rules and Regulations”**: These Rules and Regulations governing the said Contest, stated herein in entirety, as may be amended from time to time.

### **III. PROCEDURE TO PARTICIPATE IN THE CONTEST:**

#### **Questions on air**

1. A set of four (4) questions will be aired prior to initial broadcast of the Show on the Channel. Subsequently, Contest questions will be broadcast during the Episode for that day.
2. The first set of four (4) questions will be aired during the period July 22, 2011 to July 25, 2011. The subsequent questions will be aired from August 15, 2011 to November 16, 2011. The question for the Contest of the day will be broadcast at any given time between 20:30:00 hours to 22:30:00 hours of the

same day, or around that time, as determined by Channel management. Post the completion of the Episode, the question will be available on the website ([www.kbc.setindia.com](http://www.kbc.setindia.com)) until the closure of lines.

### **Participation**

1. Home Viewers may participate in the Contest by calling on the IVRS or by sending an SMS. The telephone lines (not PCO's) (mobiles and landlines) and SMS acceptance for each question shall be as per the following schedule:

2. Episode number 1 to be telecast on 15<sup>th</sup> August, 2011 will be a live episode. The above mentioned schedule could be added to, modified or

cancelled based on programming requirements and in such an event, the Show will be extended, cancelled or terminated early as decided by the Channel management.

3. In case the calls and/or SMS (“Entry”) are made after the lines have closed, or calls are in progress when the lines are closed each day, or SMSs sent are not received by the timelines as defined above, the said Entry (ies) shall not be deemed as a valid Entry. Premium rates for SMS and calls shall be applicable. Please check with your respective service providers for the same. Roaming rates may apply.
4. The cellular/landline number from which the registration is received will be used to identify the Participant as a unique identification number. We urge participants to use numbers where they would be clearly identified as the Participant of the Contest. Each Participant shall be entitled to submit multiple entries. Entries sent each day shall be considered for the random selection process as per the schedule below:

  - a. KBCQ <Space>A/B/C/D
  - b. In case of error in SMS format, the response message will read “Invalid entry. Please re submit your entry in the format KBCQ <Space>A/B/C/D”
  - c. The acknowledgement message will read “Thank you for participating for GBJJ. We will call you back on this number if you are selected. Kindly answer the phone yourself.”

  - b. Punjab and Rajasthan landlines subscribers shall dial 125551 1/2/3/4 (i.e. call 125551 and 1 for option A, 2 for option B, 3 for option C and 4 for option D).
  - c. The call will end with a thank you note/play back option. Thank you message will inform Participants that if they are selected for the next stage, they will be called back on the same number.

2. A telephonic audition will be conducted for all Shortlisted Participants as per a pre defined format. The Shortlisted Participants will be scored on the basis of the telephonic Audition.
3. The Episode Winner of the Contest will be selected in descending order of scores obtained in the telephonic audition. A Shortlisted Participant who has already been declared as an Episode Winner in any previous Episode of the Show will not be eligible to be declared as an Episode Winner for future Episodes.
4. The randomization process to select the Shortlisting Participant(s) will be undertaken with the help of a randomizer software developed specifically for the purpose of selection. In the event of a software failure, Channel management may adopt any other methodology or criteria to select the

- Shortlisted Participants, depending upon requirement and availability of time.
5. The total Short listing Participant's, timelines and methodology of determining winners are subject to change based on programming / creative requirements, degree of participation, technical issues, force majeure reasons, etc.
  6. In case of breakdown of network infrastructure (non-receipt of telephony data and/or failure of telephone lines) for the 1<sup>st</sup> Episode ("live episode"), data received for questions 1, 2, 3 and 4 will be used for shortlisting of Participants for the live episode.
  7. The same question(s) will be used for the telephonic audition of Shortlisted Participants for each episode.
  8. As part of the telephonic audition, the Shortlisted Participants will be evaluated on the criteria of:
    - a. Knowledge and awareness / personality
    - b. Communication skills
    - c. X-Factor (including but not limited to charisma, talent, back-story, education, occupation, etc.)

### **Jackpot Winner Selection**

1. The Episode Winner will receive a call from the Company / Producer half an hour before the Show verifying his / her credentials, and on the basis of a successful verification, informing him / her of selection as an Episode Winner.
2. The host of the Show will inform the Episode Winner of the episode Prize then offer the Episode Winner an option of answering a Jackpot Question to participate for the Jackpot Prize.
3. If the Episode Winner opts to not answer the Jackpot Question, he / she will be declared as eligible for the Episode Prize
4. If the Episode Winner opts to answer the Jackpot Question, and answers it incorrectly, he/she will be declared as ineligible for both, the Episode Prize and Jackpot Prize. The Episode Prize will be carried forward to the next Episode.
5. If the Episode Winner opts to answer the Jackpot Question, and answers it correctly, he/she will be declared as eligible for the Jackpot Prize along with the Episode Prize.

There shall not be a carry forward of the Episode Prize from the Live Episode (s), if any. **Call back**

1. Channel and Company are not responsible if the call-back is not successful due to:
  - a. Line being busy
  - b. Congestion on the network

- c. No answer received
  - d. Poor call conditions / unclear reception
  - e. Number engaged
  - f. Call drop
  - g. Other reasons that could render a call unsuccessful or terminate it.
2. In spite of making 2 attempts, (one (1) attempt in case of a live episode) for all Shortlisted Participants, if the Company / Producer is unable to contact them, the Company shall not be liable by the Shortlisted Participant on grounds of not being contacted.
  3. The selected Participant will receive a call from the Company / Producer and the selected Participant must confirm the details asked for by the Company / Producer immediately. The Company / Producer will ask the Participant to confirm if he/she has sent the Entry for participation in the Contest. If the confirmation required or the other information asked for is not provided on the call, then the Company / Producer will call the Shortlisted Participant once again after 15 minutes from the initial telephone contact (except for live Episodes), asking for the same details. Failure to provide such details during the second call shall lead to disqualification of such Participant from the selection process. The Company will attempt to arrange for the call backs between 9 am and 9 pm only except in the live episodes.
  4. The first person who answers the registered phone number and claims/confirms that he/she is the Participant, will be considered as the Participant as per the Rules and Regulations of the Contest. The Company / Producer will not be responsible to determine the correct Participant in the event of more than one Home Viewer having participated from a particular number, or the incorrect person answers the call and claims to be the Participant, or refuses to permit the actual Participant to continue the call.
  5. Company will use their best efforts to contact the selected Participant, but will not be responsible or liable in any way whatsoever if the Participant cannot be reached by telephone, on the number provided, within the next 15 minutes after initial contact is made or after the first attempt of reaching the Participant (except for live Episodes).
  6. The following process will be followed by the Company / Producer once connected with the randomly selected Shortlisted Participants for the telephonic audition call-back:

- a. If the receiver of the call confirms that he/she is the Participant, then the Participant will have to choose between Hindi & English language options.
  - b. The Participant is informed that the call is being recorded and also confirms that the Contest is subject to the rules and regulations available on the Channel website and the Participant agrees to abide by such rules.
  - c. The Company / Producer will then ask the Participant to provide his/her Name and Address.
  - d. The Company / Producer will record the details provided by the Participant and ask for his/her date of birth, nationality and Permanent Account Number (PAN).
  - e. If the details provided by the Participant indicate that the he/she is not an Indian and / or does not possess a PAN and/or is a minor, then only one further opportunity will be provided to such selected Participant to revise/ confirm their answer, after which the call will be terminated and the Participant deemed disqualified and thus ineligible to be a Shortlisted Participant to receive the prize money.
  - f. If the details provided by the Participant indicate that he/she is an Indian national, not a minor and possesses a PAN card; the Company / Producer will proceed to check the availability of the Shortlisted Participant for the shoot dates.
  - g. If the Shortlisted Participant is available for the shoot dates at the specified time. The Participant is also informed that the audition question does not automatically ensure the Participant's place on the Show The Company / Producer will then ask the Shortlisted Participants the audition questions and end the call.
7. The following process will be followed by the Company / Producer once connected with the randomly selected Shortlisted Participant for the pre-shoot call-back:
- a. The pre shoot call back will take place upto 30 minutes prior to shoot commencement. This pre shoot call back timings shall not be applicable in case of live episode.
  - b. If the receiver of the call confirms that he/she is the Participant, then the Participant will have to choose between Hindi & English language options.
  - c. The Company / Producer will then ask the Participant to provide his/her Name, Date of Birth, PAN and Address.

- d. The Company / Producer will confirm the details provided by the Participant
  - e.
