Terms and Conditions for "Kaun Banega Crorepati" Contest

The following terms and conditions ("**T&Cs**"/ "**Terms and Conditions**") shall be applicable to Sony Pictures Networks India Private Limited (Formerly known as Multi Screen Media Pvt.
